

Privacy Policy

1. Basic Policy

Japan Entertainment Tours Co., Ltd. (hereinafter referred to as the “Company”) collects and uses personal information of users only to the extent necessary for the smooth operation of the services it provides.

The Company shall handle all collected personal information appropriately and within the scope of the purposes of use.

2. Scope of Information Collected and Purposes of Use

The personal information collected by the Company shall be limited to the minimum necessary for the operation of travel services, including information that requires special consideration.

The Company and its group companies may use the personal information provided by customers for communication with customers, for arranging travel-related services, and for procedures necessary for customers to receive such services.

The Company may jointly use customers’ personal data (such as name, address, telephone number, and email address) with its group companies, limited to the minimum extent necessary for communication with customers.

3. Restrictions on Use and Provision

The Company shall not use collected personal information for purposes other than those stated, nor provide such information to third parties, except in cases required by laws and regulations, or in cases involving illegal activities such as unauthorized access or threats, or other special circumstances.

When outsourcing the processing of personal information to third parties, the Company shall select contractors with due care and shall endeavor to ensure appropriate supervision and management equivalent to that of the Company.

4. Security Measures

The Company shall take necessary and appropriate measures to manage collected information securely and to prevent leakage, loss, or damage of personal information.

5. Disclosure, Correction, and Deletion of Personal Data

Customers who wish to request disclosure, correction, addition, deletion, suspension of use, deletion, or suspension of provision to third parties of their personal data may contact the inquiry desk designated by the Company.

Upon confirming the identity of the customer, the Company shall take appropriate measures within a reasonable period in accordance with applicable laws and regulations.

If the Company is unable to respond to all or part of the request, it shall provide an explanation of the reason.

6. Use of Cookies and Similar Technologies

This website may use cookies, web beacons, and similar technologies for the following purposes:

- (1) To provide customized services by referring to registered information when users log in to authentication services;
- (2) To display appropriate advertisements on other websites based on users' interests and usage of this website;
- (3) To analyze the number of users and traffic of this website;
- (4) To improve the Company's services; and
- (5) To maintain security, including prompting re-authentication after a certain period of inactivity.

Information stored through cookies does not include personally identifiable information such as names or telephone numbers.

The Company may revise this Privacy Policy as necessary. In such cases, the revised policy shall be announced on this website.
